Mo. Applicant shall inspect the property before vegetation control and evaluate all potential risks, both seen and unseen. Applicant waives all rights to claims against the Commission and MoDOT and its employees or officers arising due to injuries resulting from the actions of applicant, its agents, officers, employees or assigns under the permit.
